- HOTELS:** All reservations are made on a first come basis. If the rooms you request are not available then you will be contacted and offered alternative arrangements.
- YOUR TOUR CONTRACT:** At the time of asking for a booking to be made on your behalf, you must complete and sign a booking form agreeing to accept the booking conditions as set out below. Your contract is entered into on the terms and conditions of these booking conditions and the completed booking form must be received accompanied by the appropriate deposit or full payment, at which time, subject to availability of the particular tour, your contract with us is made.
- DEPOSITS AND PAYMENT:** No booking can be accepted unless accompanied by a minimum deposit of **€ 125** (approximately £85) per person. This is your only commitment until 5 months before departure. Payment of the balance remaining after deducting the deposit from the total cost of the tour as expressed in our confirmation/invoice, will be due without further notice 20 weeks before your date of departure. If final payment is not received by that due date, the Kemmel Historic reserves the right to treat your booking as cancelled and you could be liable to pay cancellation charges in accordance with the section below entitled cancellations. Alternatively if your booking form and tour place is received and confirmed by the Kemmel Historic, less than 20 weeks before departure, the full tour price will be requested upon booking.
- PASSPORTS:** For non EU Passport holders please contact this office for Visa requirement information.
- PRICES:** The price of your tour is subject to variation by reference to elements covering taxes, and exchange rates. All bank cost are for you.
